The European Climate, Infrastructure and Environment Executive Agency (hereinafter referred to as "the Agency"), acting under powers delegated by the European Commission (hereinafter referred to as "the Commission"), and represented for the purposes of signature of this amendment by **Hans RHEIN**, Head of Unit, or his duly authorised representative,

WHEREAS

(1) The grant agreement No **LIFE20 CCA/HU/001604**, hereinafter referred to as "the grant agreement", entered into force on 02/07/2021,

(2) The coordinating beneficiary Ministry of Interior (MoI) has undergone a reorganization and the competences for local government, including the grant agreement, have been reassigned to the Ministry of Public Administration and Regional Development (MoPARD);

(3) The coordinating beneficiary Ministry of Public Administration and Regional Development (MoPARD) has been added to the Grant Agreement.

(4) Article I.5 of the grant agreement has been revised,

(5) Article I.6 of the grant agreement has been revised,

(6) Annex IV to the grant agreement (mandates provided to the coordinating beneficiary by the other beneficiaries) has been revised,

(7) The coordinating beneficiary has the mandates of all associated beneficiaries participating in the grant agreement for the purpose of the signature of this amendment.

Have agreed as follows:

Article 1

The grant agreement LIFE20 CCA/HU/001604 (hereinafter referred to as "the grant agreement") is modified as follows:

(1) Forms A1/A2/A3/A4/FC as set out in Annex II of the grant agreement are amended as set out in the new Forms A1/A2/A3/A4/FC as attached.

(2) Forms A2 and A3 of Ministry of Public Administration and Regional Development (MoPARD) are added to Annex II.

(3) The coordinating beneficiary Ministry of Interior (MoI) as set out in the Annex II to the grant agreement is replaced by the Ministry of Public Administration and Regional Development effectively from 31 December 2023 and its financial and technical commitments are assumed by the Ministry of Public Administration and Regional Development (MoPARD) according to the specifications included in Forms (A1, A2, A3 and FC), effectively from 1 January 2024. Any reference to Ministry of Interior (MoI) in the grant agreement shall be understood, where appropriate, as a reference to Ministry of Public Administration and Regional Development (MoPARD).

(4) Article I.5 of the grant agreement is replaced by

With the exception of the modifications introduced by the present amendment, all other provisions of the grant agreement remain in full force. This amendment No 1 forms an integral part of the grant agreement.

This amendment will enter into force on the day of the last signature of the parties to the grant agreement.
